**Admission Arrangements 2027/2028** Curzon C of E Combined School is part of the Oxford Diocesan Bucks Schools Trust (ODBST), who are the admissions authority for the school. The Board of Trustees works in partnership with the Local Governing Body of the school over the consultation and operation of the individual schools' admissions policy.

The ODBST and the Local Governing Body (LGB) have made every effort to ensure that these arrangements comply with the School Admissions Code 2021 and all relevant legislation, including infant class sizes and equal opportunities.

In reviewing this policy the ODBST has had regards to the Equality Act 2010. It is satisfied that no group with a protected characteristic will be unfairly disadvantaged.

The Trust consulted on Curzon C of E Combined School School's admission policy in **2022-23**.

### **Admission arrangements to the Reception Year in September 2027**

Pupils are normally admitted at the beginning of the school year (**1 September 2027 – 31 August 2028**) in which they reach their fifth birthday. Parents whose child was born between **1 September 2022** and **31 August 2023** may apply for them to be admitted to the Reception Year in **September 2027**.

**There are 20 (the published admission number or PAN) places available.**

Note: In line with current DfE guidance (November 2024), admission authorities should carefully consider all requests for admission outside the normal age group. The Department for Education supports the right of parents to decide their child will not start school until compulsory school age, but does not believe it should become the norm for summer born children to begin reception at age 5, as most summer born children will thrive if they are admitted to reception aged 4. The DfE has confirmed they no longer intend to change the law on the admission of summer born children because the system is working much better than in the past. Decisions will be made on the basis of the circumstances of each case and in the individual child's best interests.

Parents of a child whose fifth birthday falls between **1 September 2026** and **31 March 2028** may defer entry until their child reaches compulsory school age (the term beginning in **January 2028** or **April 2028** after his or her fifth birthday). The school will hold the deferred place for the

child (provided it is taken up during the school year **2027/28**), although children may benefit from starting at the beginning of the school year, rather than part way through it.

For children whose fifth birthday falls between **1 April 2028** and **31 August 2028** (summer born children) who do not reach compulsory school age until **September 2028** i.e. the term after they reach their fifth birthday, parents who do not wish them to start school in school year **2027/28** but want them to be admitted to the Reception Year in **September 2028** should proceed as follows:

They should apply at the usual time for a place in **September 2027** together with a written request that the child is admitted outside his or her normal age group to the Reception Year in **September 2028**. NB: parents would need to provide supporting reasons for seeking a place outside the normal age group and should discuss the position with the Headteacher as early as possible. Whether to grant the request is a school decision and the school will consider the request carefully. If it is agreed, this should be clear before the national offer day, so their application for the normal age group may be withdrawn before any place is offered. They should then reapply in the normal way for a Reception Year place in **September 2028**.

If their request is refused, the parents must decide whether to wait for any other offer of a place in **September 2027** (NB: it will still be subject to the over-subscription criteria below) or to withdraw their application and apply in the second half of the of the **summer term 2028** for a Year 1 place in **September 2028**. Parents should be aware that the Year 1 group may have no vacancies and it could be full with children transferring from the **2027/28** Reception Year group. Parents can submit a complaint if they feel that their application has not been considered properly.

**NB agreement by the school in 2027 to defer does not guarantee a place in September 2028 – the normal over-subscription criteria apply.**

Until the child reaches compulsory school age, they may attend part-time. If parents wish to exercise this right they should discuss detailed arrangements with the head teacher.

### **Application form**

Parents (see Note 1) wishing to apply for the Reception Year in **September 2027** must complete the common application form provided by their home local authority (the home LA). The home LA is the LA in whose area the parents live at the time of the application. The form must be returned to that LA no later than **15 January 2027**. Applications received after this date will normally only be considered after all those received on or before the cut-off date. Offers and refusals of places will be given to parents on **16 April 2027**.

**Admission arrangements to Year 3 in September 2027 (where applicable) in yellow**

## Admission numbers

Curzon C of E Combined School has a published admission number (PAN) of **26 for entry at Year 3**.

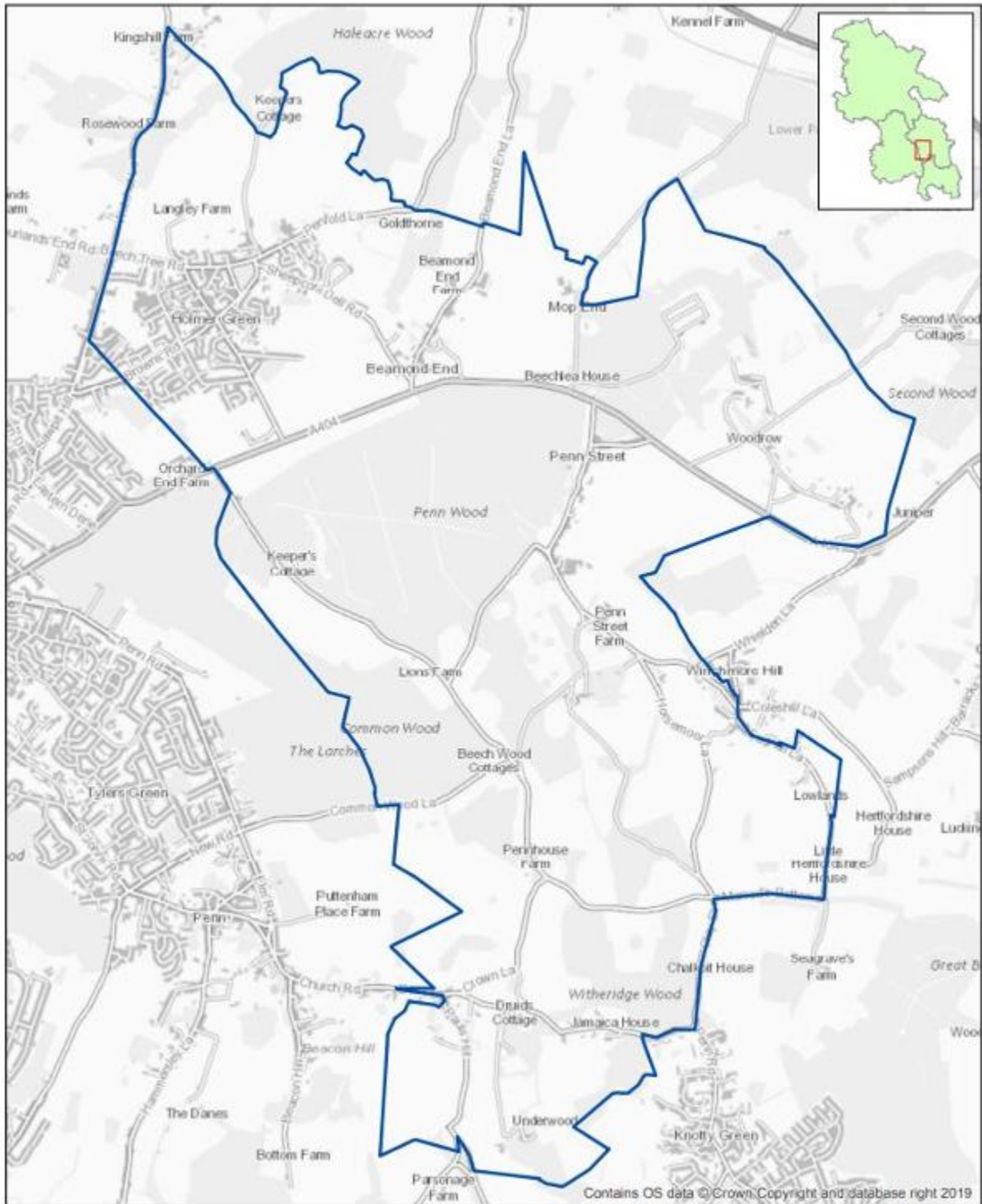
Parents (see Note 1) wishing to apply for a Year 3 place in **September 2027** must complete the common application form provided by their home local authority (the home LA). The home LA is the LA in whose area the parents live at the time of the application. The form must be returned to that LA no later than **15 January 2027**. Applications received after this date will normally only be considered after all those received on or before the cut-off date. Offers and refusals of places will be given to parents on **16 April 2027**.

## Over-subscription criteria

Children with an Education, Health and Care (EHC) plan naming Curzon C of E School will always be offered places. If there are fewer applications than places available, all children will be offered places. If there is greater demand for admission than there are places available, the following criteria will be applied in the order set out below:

1. **Looked-after children and children who were previously looked after, including those children who have been in state care outside England, but ceased to be so as a result of being adopted.** (See Notes)
2. Families who have exceptional medical or social needs that make it essential that their child attends Curzon C of E School rather than any other. These needs must be fully supported by written evidence from the appropriate professional person involved with the family. (See Notes)
3. Children with a normal home address (see Note 1) **in the ecclesiastical parish** for Holmer Green, Penn Street and Coleshill **and with a sibling** (see Note 5) on the roll of the school at the time of application or whose parent has accepted an offer of a place at the school and who is expected still to be in attendance at the time of entry to the school (see maps below).
4. Children with a normal home address **in the ecclesiastical parish** for Holmer Green, Penn Street and Coleshill (see maps below).
5. Children with a normal home address **outside** the ecclesiastical parish for Holmer Green, Penn Street, Coleshill **and** with a sibling on the roll of the school at the time of application or whose parent has accepted an offer of a place at the school and who is expected still to be in attendance at the time of entry to the school.
6. Children who attend Homer Green Pre-School, a local early years setting which works in informal partnership with Curzon CE Combined School and shares its inclusive and caring ethos. To qualify under this criterion, the child must be on roll and have attended the pre-school for at least one continuous term prior to the application closing date. Attendance will be verified by the pre-school.
7. Other children. (see Notes)

Pupils will not be admitted above the PAN unless exceptional circumstances apply.

### All Other Admissions

Admission to the school during the school year depends on whether or not there are places available. There are 20 places in year one and 20 places in year two. There are 26 places in each class in KS2

In-year applications must be made directly to the school on a form available from the school, returned promptly to the school and will be considered by the Local Governing Body.

If there is a vacancy, and there is no child on the relevant waiting list with a higher priority (according to the over-subscription criteria above), a place will be offered.

In-year admissions will be considered in accordance with the requirements of the School Admissions Code.

If parents are moving house, the school will ask for evidence of the move, when considering any application for a place. Documentary evidence in the form of a solicitor's letter to confirm exchange of contracts, or a rental agreement for at least a period of six months will be required (Armed Forces personnel are exempt). If you are returning from elsewhere, to live in a home that you own, we will require evidence to show that you have returned. We will also ask for evidence that any previous house owned has been sold or is being sold. We would not accept an address where the one given is that of a second home with the main home being elsewhere. If there are two or more homes, we will check which is the main home, and may refuse to base an allocation of a place on an address which might be considered only temporary. Nor would we accept an address where the child was resident other than with a parent or carer unless this was part of a fostering or formal care arrangement. We would not normally accept an address where only part of a family had moved, unless connected with a divorce or permanent separation arrangement, in which case we would require proof.

#### Admission outside normal age group

In line with current DfE guidance (November 2024), admission authorities should carefully consider all requests for admission outside the normal age group. The Department for Education supports the right of parents to decide their child will not start school until compulsory school age, but does not believe it should become the norm for summer born children to begin reception at age 5, as most summer born children will thrive if they are admitted to reception aged 4. The DfE has confirmed they no longer intend to change the law on the admission of summer born children because the system is working much better than in the past.

Requests from parents for places outside a normal age group will be considered carefully, e.g. for those who have missed education due to ill health. Each case will be considered on its own merits and circumstances and a decision made based on what is in the pupil's best interests. It is recommended that parents discuss their wishes with the head teacher in advance of applying for a place. The Local Governing Body may ask relevant professionals for their opinion. If a place in the requested age group is refused, but one in the normal age group is offered, then there is no right of appeal.

#### **Waiting Lists**

The school maintains waiting lists for those children who are not offered a place and the parents ask for the child's name to be added to the waiting list. The order of priority on the

waiting list is the same as the list of criteria for over-subscription and does not depend on the date on which an application is received.

No account is taken of length of time on a waiting list. The school periodically seeks confirmation that parents wish a child to be kept on the waiting list.

After National Offer Day, Buckinghamshire Council will automatically add the names of the children who have not been offered a place at School Curzon C of E Combined School to the waiting list for the school. If you don't remove your child from the waiting list and the Local Authority is able to offer you a place at a higher preference school, they will automatically re-allocate your original offer to another child. It is important to inform the school and Local Authority if you no longer want your child's name to be included on a waiting list. Details of these arrangements are available on Buckinghamshire Council's admissions websites.

The school maintains waiting lists for those children who are not offered a place in other year groups, and the parents ask for the child's name to be added to the waiting list. The order of priority on the waiting list is the same as the list of criteria for over-subscription and does not depend on the date on which an application is received. No account is taken of length of time on a waiting list. The school periodically seeks confirmation that parents wish a child to be kept on the waiting list.

### **Multiple births**

In cases where there is one place available, and the next child on the list is a twin, triplet, etc., we would admit both twins (and all the children in the case of other multiple births) even if this meant exceeding the agreed admission number of **20 for Reception and 26 for Year 3 in 2027/28** or the number of places in other year groups (**20 for Years 1 and 2 and 26 for years 4 - 6**).

### **Fair Access**

The school participates in the LA's Fair Access Protocol. Children qualifying under the Fair Access Protocol may be offered a place even if there are no places available in the relevant year group and also take priority for admission over any child on the waiting list.

### **Appeals**

Any parent not offered a place for their child at their preferred school has the right of appeal to an independent appeals panel. Details of appeals arrangements are available from the school, including the date by which an appeal should be submitted. In the event of an unsuccessful appeal against non-admission to the school, the school will not consider any further application for a child in the same school year (**1 September 2027 – 31 August 2028**), unless there has been a material change in circumstances, for example a change of address which results in a move from outside the catchment area to inside it.

## **Admissions in September 2026 (This information will be added once known)**

The school received 46 applications expressing a preference for admission to the Reception Year in **2026** by the closing date in **January 2026**. These were ranked as follows:

### **Infant Class Size Compliance**

Reception classes (where the majority of children will reach the age of 5, 6 or 7 during the school year) must not contain more than 30 pupils with a single school teacher. Additional children may be admitted under limited exceptional circumstances as 'excepted pupils':

a) Children admitted outside the normal admissions round with Education, Health and Care Plans specifying the school

**b) Looked after children and previously looked after children admitted outside the normal admissions round**

c) Children admitted after initial allocation of places, because of a procedural error made by the admission authority or local authority in the original application process

d) Children admitted after an independent appeals panel upholds an appeal

e) Children who move into the area outside the normal admissions round for whom there is no other available school within reasonable distance

**f) Children of UK service personnel admitted outside the normal admissions round**

g) Children whose twin or sibling from a multiple birth is admitted otherwise than as an excepted pupil

h) children with special educational needs who are normally taught in a special educational needs unit attached to this school, or registered at a special school, who attend some infant classes within the mainstream school

## Right to Appeal

When the school informs a parent of a decision to refuse their child a place, it must include:

- The reason why admission was refused
- Information about the right to appeal
- The deadline for lodging an appeal
- The contact details for making an appeal

Parents must be informed that, if they wish to appeal, they must set out their grounds for appeal in writing. The school must not limit the grounds on which appeals can be made.

## Notes to the admissions policy

The following are detailed notes referring to the definitions in use for this school's policy.

### Note 1:

'Parent' is defined in law (The Education Act 1996) as either: a) any person who has 'parental responsibility' (defined in the Children Act 1989) for the child or young person; or b) any person who has care of the child or young person.

If you are in any doubt, please contact the school for advice.

### Note 2:

A 'looked-after child' is one in the care of a local authority or being provided with accommodation by a local authority in the exercise of its functions. Previously looked after children are children who have been adopted, subject to child arrangement orders or special guardianship orders. Adopted children are those for whom an adoption order is made under the Adoption Act 1976 (Section 12) or the Adoption and Children Act 2002 (Section 46). A 'child arrangements order' is one settling the arrangements to be made as to the person with whom the child is to live (Children Act 1989, Section 8, as amended by the Children and Families Act 2014, Section 14). A 'special guardianship order' is one appointing one or more individuals to be a child's special guardian/s (Children Act 1989, Section 14A).

**Applications under this criterion must be accompanied by evidence to show that the child is looked after or was previously looked after (e.g. a copy of the adoption, child arrangements or special guardianship order). A 'looked-after child' includes any child who appears to have been in state care outside England if they were in the care of or were accommodated by a public authority, a religious organisation, or any other provider of care whose sole or main purpose is to benefit society.**

### Note 3:

Applications under criterion 2 (exceptional medical or social needs), must be supported by evidence from an independent professional person which clearly demonstrates why the school

is the most suitable and must illustrate the difficulties that would be caused if the child had to attend another school. The person supplying the evidence should be a doctor, health visitor, social worker, etc. who is aware of the circumstances of the case. The school reserves the right to ask for further evidence or clarification where necessary and may seek the advice of appropriate professionals where necessary.

**Note 4:**

The home address is where the child normally lives. This will be where the parent or legal carer of the child lives with the child unless it is shown that the child is resident elsewhere with someone else who has legal care and control of them. The address should be a residential property that is owned, leased or rented by the child's parent/s or person with legal care and control of the child.

Where a child lives with parents with shared responsibility, each for part of a week or month, the address where the child lives will be determined having regard to a joint declaration from the parents stating the exact pattern of residence. If the residence is not split equally, then the relevant address used will be that at which the child spends the majority of the school week. Where there is an equal split or there is any doubt about residence, the home address will be assumed to be the address at which the child is registered with a GP.

Evidence of the normal home address may be requested in the form of a recent bill, for example, the most recent Council Tax bill, utility bill no more than three months old, a current TV licence, buildings and contents insurance, mortgage statement or rent book which shows the address concerned.

If a place at the school is offered, and it later becomes clear that the offer was made on fraudulent or misleading information (e.g. a false claim to living in the catchment area), and the school has denied a place to a child with a stronger claim, the school will withdraw the offer of a place. The offer can be withdrawn even after the child has started at the school.

If parents are moving house, evidence of the move will be requested when considering any application for a place. Documentary evidence in the form of a solicitor's letter to confirm exchange of contracts, or a rental agreement for at least a period of six months will be required.

If parents move house after the application has been made, but before any offer of a place has been made, the home LA must be informed.

An address of a second home with the main home being elsewhere will not be accepted. If there are two or more homes, or where a family is returning from elsewhere, evidence will be required of the main home. An allocation of a place based on an address which might be considered only temporary or where the address given is a second home will not be made.

An address where the child was resident other than with a parent or carer unless this was part of a fostering or formal care arrangement will not be accepted.

**There are special arrangements for families of service personnel with a confirmed posting or crown servants returning from overseas. If the application is accompanied by an official**

**letter that declares the relocation date, and if there is a place available, it will be offered even though there is not an intended address or the family is not yet living in the area.**

**Note 5:**

'Sibling' means a natural brother or sister, half-brother or sister, adopted brother or sister, step-brother or sister, or the child of the parent's/carer's partner where the child for whom the school place is sought is living in the same family unit at the same address as that sibling. It is helpful if parents make it clear on the application form where the sibling has a different family name. Where there is more than one sibling at the school, only the youngest should be listed on the application form.

Siblings of children who are attending the school in Year R to Year 6 at the time the allocations are made (March 2027), and are expected to be on the school roll at the time of the proposed admission, or who have already been offered a place to start in the current academic year at the school.

**Note 6:**

The straight line distance used to determine proximity of the home to the school will be measured by the LA's Geographical Information. They use straight line distance for admissions purposes. This is the distance from your child's normal home address and set out by the ordnance survey to the nearest open school gate available for pupils to use. The point the LA measure to at your child's address is determined by the ordnance survey ADDRESS-POINT which is an ordnance survey data product that provides a national grid coordinate and a unique reference for each postal address in Great Britain that is on the Royal Mail's address file. This is different to the shortest walking route which is used for transport purposes.

Proximity of the child's home, as measured by the straight-line distance (see Note 6) between the home and the school with those living nearer being accorded the higher priority, will serve to differentiate between children in criteria 1 to 7 should the need arise. In the event that two distance measurements are identical, the school will use random allocation to decide which child should be offered the place. The process will be conducted in the presence of a person independent of the school.

**Objections to and referrals about the determined school admission arrangements**

Members of the public can make an objection to the Office of the Schools Adjudicator (OSA) if they think that the admissions arrangements of a maintained school or an academy do not comply with the 'School Admissions Code' (the Code) or other legislation relating to school admissions.

All admissions authorities must determine their admission arrangements by **28 February** every year, even if they have not changed from previous years and a consultation has not been required. **Complainants have until 15 May to contact the adjudicator if you have an objection.**
